The European Bars Federation (FBE) is proud to celebrate her 30th Anniversary in Palermo!

Established in 1992, the Federation connects approximately one million lawyers across the Council of Europe. The principles and objectives of the work of the FBE are to defend the fundamental principles of the European Convention on Human Rights, to guarantee the services of independent lawyers for individuals, institutions and corporations, to create an independent organization which ensures respect for the essential principles of the profession of the lawyer in Europe and to seek recognition of the particular role fulfilled by the European Bars in the defense of all liberties against every political, economic and judicial authority. Therefore, the title of the present scientific program of the congress “Lawyers under Attack” has been chosen to honour the courageous colleagues in the raging war within the borders of Europe. Who would have thought that such a terrible conflict could arise in post-war modern Europe? The fallout of this war stretches beyond the borders of Ukraine. Bars and individual lawyers are aiding refugees, among whom are also lawyers. In further discussions on the theme of the congress it was noted that at the same time, the profession is also ‘under attack’ because lawyers are being physically threatened, for example while doing their everyday work in big criminal cases. Another observation throughout Europe is that governments are not always on the side of the lawyer when it concerns core values of the profession. The professional privilege is often considered a hindrance, the importance of privacy is not recognized in favor of monitoring the movements of the individual, even if such citizen is a not suspected of a crime. The third theme, last but certainly not least, concerns the attack on the profession by contemporary challenges including but not limited to a commercial pressure, which reads 24/7 availability of a lawyer for work thus affecting a healthy work-life balance. These themes will be discussed by more than 20 speakers, including the most distinguished guests such as: the Deputy Minister of Justice of Portugal, the Expert on the Protection of Lawyers from the Council of Europe and the former Vice President of the European Commission and we cordially thank them for their contribution beforehand!

As always in the last three centuries, the gathering of the Commissions and the Forum des Bâtonniers will provide an inspirational discussion about the profession to many.

The FBE thanks the Palermo Bar for her kind invitation to host this congress in her beautiful city, and for all the efforts by the organizational team. We very much look forward to the exchanges and views of the European colleagues and the famous Sicilian hospitality.

Furthermore, the need for cooperation between the European Bar Associations on issues that affect the entire European area in the defence of the Rule of Law will be confirmed.

Also at this Congress there will be the Conference of Presidents to strengthen the relations between the twinned Bar Associations and find new partners.

At the end we will all celebrate the 30th Anniversary of Federation des Barreaux d'Europe.
