

**The Honorable Stephen G. Breyer, Associate Justice Supreme Court of the United States**

Justice Breyer is a graduate of Stanford, Oxford, and Harvard Law School. He taught law for many years as a professor at Harvard Law School and at the Kennedy School of Government.



**John B. Bellinger, III, Partner**

Partner at Arnold & Porter after holding several senior Presidential appointments in the US government, including as the Senate-confirmed Legal Adviser to the Department of State and Senior Associate Counsel to the President and Legal Adviser to the National Security Council (NSC) at the White House in the George W. Bush Administration.



**The Right Honourable Kim Campbell, 19<sup>th</sup> Prime Minister of Canada**

Ms. Campbell has spent much of her life breaking barriers for women. She served at all three levels of government in Canada. After leaving politics she served as the Canadian Consul General in Los Angeles, then taught at the Harvard Kennedy School, after which she became an international leader of leaders with organizations such as the International Women's Forum and the Club de Madrid.



### **Harold Koh, Sterling Professor of International Law**

Mr. Koh returned to Yale Law School in January 2013 after serving for nearly four years as the 22nd Legal Adviser of the U.S. Department of State. Professor Koh is one of the country's leading experts in public and private international law, national security law, and human rights.



### **Sandie Okoro, Senior Vice President and General Counsel**

Ms. Okoro is the Senior Vice President and General Counsel for the World Bank Group, and Vice President for Compliance at the World Bank. She is also the Chair of the World Bank Group Task Force on Racism. As the first British national and the first black woman to hold this role, Sandie is the principal advisor and spokesperson on all legal matters for the world's leading development finance institution.



### **Todd Owen, Former Executive Assistant Commissioner (EAC)**

Mr. Owens served with the U.S. Customs and Border Protection (CBP), Office of Field Operations (OFO), As the senior executive for the Office of Field Operations for over 5 1/2 years. Mr. Owens was responsible for all operations at the 328 ports of entry in the U.S., as well as overseas operations in 32 countries.
