

## **Panelists**

## Hon. Ural D. Glanville



The Honorable Ural D. Glanville is a 1987 graduate of the UGA School of Law. After completing his J.D., he served on active military duty for several years, returning to Atlanta in 1993. He served as a prosecutor, criminal defense attorney, and civil litigator prior to beginning his judicial service, in 1996, as a Magistrate Judge in Fulton County State Court. In 2004, after eight years behind the magistrate bench, Judge Glanville was elected to serve as a Superior Court Judge in Fulton County. In his nearly twenty years on the Superior Court bench, Judge Glanville has presided over a wide array of matters ranging from domestic relations to felony offenses to negligence claims to bond validations. All the while, Judge Glanville continued to pursue his military career with the Army Reserves that began during his undergraduate years at UGA. Now a retired Brigadier General, Judge Glanville proudly served for 35 years. Judge Glanville is married to Lisa B. Glanville; the couple has two adult children.

## Hon. LaTisha Dear Jackson

The Honorable LaTisha Dear Jackson was first elected Superior Court Judge of the Stone Mountain Judicial Circuit in 2018 and was reelected without opposition in 2022. In both 2021 and 2022, Judge Jackson was selected to serve by designation as a Justice of the Supreme Court of Georgia on two separate cases. Her service in 2022 was historic in that it was the first time the Supreme Court had an all-woman bench preside over oral arguments. After just nine months in office, Judge Jackson began serving as a Presiding Judge over one of the Circuit's Drug Court. After a year of service, Judge Jackson was unanimously elected to serve as the Presiding Judge for the Circuit's four Accountability Courts. In 2022, Judge Jackson was elected to serve as the Chief Judge of the Stone Mountain Judicial Circuit as well as the Administrative Judge for the Fourth Judicial Administrative District which is comprised of DeKalb and Rockdale Circuits.



Immediately before her election, Judge Jackson was a Senior Associate at Thomas Kennedy Sampson & Tompkins, LLP ("TKST"). There, she defended

corporate and governmental clients in medical malpractice, wrongful death, premises liability, and insurance matters. She also represented individuals in personal injury and wrongful death matters. Prior to joining TKST, Judge Jackson served as a full-time judge in the DeKalb County Recorders Court and sat by designation in both the Superior and State Courts of DeKalb County. For over a decade, Judge Jackson served as a judge in local courts.

In 2008, she made history by becoming both the first female and youngest judge to ever serve as a Municipal Court Judge in the City of Stone Mountain and in 2012, she again made history by becoming the first female Chief Municipal Court Judge in the City of Lithonia. Prior to becoming a member of the judiciary, Judge Jackson was a solo practitioner handling juvenile and family law matters as well as criminal defense. Judge Jackson also served as an Assistant Solicitor General in DeKalb County. Judge Jackson earned her Juris Doctorate from Georgia State University and her undergraduate degree from the prestigious Spelman College. A native of Los Angeles, California, Judge Jackson is active in numerous professional organizations.

For the past eight years she has served on the Georgia-Statewide Access to Justice Committee, where she continually works to ensure that there is unfettered access to the courts by litigants and the public as they navigate the judicial system. Judge Jackson also chairs the complementing committee for the Superior Courts of Georgia. Judge Jackson is an active member of several bar organizations including without limitation - the Georgia Association of Black Women Attorneys, Georgia Association for Women Lawyers, the Atlanta, DeKalb and Gate City Bar Associations and DeKalb Lawyers Association where she served an unprecedented two-year term as President and currently serves as the Judicial Section and Review Committee Chair. Judge Jackson is the Immediate Past Chair of the State Bar of Georgia's Judicial Section after serving as Chair for three years. She is also a Past President of the Georgia Council of Municipal Court Judges and a current member of the State's Judicial Council. In her community, Judge Jackson has served on the Board of Directors for the Georgia Center for Children and is a 2006 graduate of Leadership DeKalb, where she currently served as a Board of Director and on the Selection Committee, a committee she's chaired for over a decade.

Judge Jackson currently serves as a DeKalb County Board Member for Boys and Girls Club Metro Atlanta and is a proud twenty-six-year active member of Alpha Kappa Alpha Sorority, Inc. Judge Jackson has traveled throughout both the Southeastern United States and State of Georgia presenting on various judicial and legal issues with a passion for professionalism and access to justice. She also speaks at various schools throughout the metro-Atlanta area. As a continued investment to the youth, Judge Jackson created a three-year program in the DeKalb County Public School System entitled I. L.E.A.D. (Interactive Law and Education Development) Program, a program that focused on educating high school students on the law while strengthening their comprehension and writing skills. Judge Jackson not only works and serves DeKalb County, but she also resides there calling it home with her husband Gari Jackson. She is a member of Ray of Hope Christian Church.

As a testament to her accomplishments, she has received several honors, been featured in several newspapers and magazines as well as her sorority's international magazine. She has also been honored by her sorority, several county and city associations and elected leaders including receiving the Council for Municipal Court Judges President's Award for her commitment to access and fairness in Georgia courts. In all that she does and has accomplished thus far, Judge Jackson remains humbled, inspired, and motivated to continue to seek justice because there are still so many lives left to be touched.

#### Hon. Kevin M. Farmer



The Honorable Kevin M. Farmer, Judge of the Superior Court of Fulton County, has served on the bench since 2018. He is presently presiding as one of the judges in the Family Court Division.

Judge Farmer began his legal career in 1996 after graduating from Mercer University Law School. He served in the Fulton County Public Defender's office from 1997 to 2001. In 2002, Judge Farmer went into private practice where he practiced, among other things, family law. He also served as a Guardian ad Litem representing the best interests of children in custody disputes. Thereafter, Judge Farmer returned to public service as the Senior Attorney for the Metro Conflict Defender's Office (Division of the Georgia Public Defenders Council), and then as the Senior Assistant District Attorney in the Clayton County Judicial Circuit.

#### Hon. Alice Benton

As the Superior Court of Fulton County's most recent addition to the Bench, the Honorable Alice Benton brings with her a wealth of family law knowledge and experience. Prior to her appointment to the Bench on January 10, 2024, Judge Benton had a thriving family law practice handling divorces and serving as a Guardian ad Litem. Judge Benton also has extensive criminal law experience as a former Senior Assistant District Attorney in Fulton County, and as an Assistant Solicitor in Cobb and Forsyth Counties. As a member of the Fulton, Cobb, Gwinnett and Forsyth County Bar Associations, Judge Benton has always been actively involved, having served on the State Bar Family Law Legislative Committee, as Treasurer for the Cobb Bar Association, and as President of the Cobb Bar Family Law Section. She is a member and the current President of the Charles L. Weltner Inn of Court, and a member of the Georgia Association for Women Lawyers. Judge Benton also enjoys serving her community. She is affiliated with the Cherokee Chapter of the National Society of the Daughters of the American Revolution, and has been a Board Member for the Cathedral of St. Philip Cathedral Preschool for



seven years. In addition to other community activities, Judge Benton volunteers for the Lovett School Linebackers, is a Sustaining Member of the Atlanta Junior League, and a Patroness of the National Charity League.

## M. Debra "Debbie" Gold



M. Debra Gold (Debbie) started her legal career in 1989 under the tutelage of Jack P. Turner, one of the great pioneers of Family Law in Georgia. Family law has always been her calling. Since 2004, Debbie's practice has focused primarily on serving as a court-appointed Guardian ad Litem. In 2018, she opened the doors to *mdg* Custody Litigation Consulting, putting her years of experience to work consulting with, and doing contract work for other attorneys involved in high conflict custody cases.

Debbie is involved in the family law Bar in several capacities. She was a

founding Board member of the DeKalb Bar Association Family Law Section and served on the Board for six years. As Chair, she spearheaded, organized and lectured for the annual *Not Your Everyday Custody Case* continuing legal education series. Debbie also established the Section's charitable partnership with Nia's Place, Supervised Visitation and Exchange Center. In addition, she represented the Family Law Section as a Board Member of the DeKalb Bar Association from 2013 – 2015.

Early in her career, Debbie also served as the Associate Editor for the State Bar of Georgia Family Law Section newsletter (now The Family Law Review) and she has been a regular contributor to the publication since. Debbie also volunteers with DeKalb Pro Bono, and formerly with the Atlanta Volunteer Lawyers Foundation, and she has organized and lectured at Guardian ad Litem trainings for both organizations. She is a founding Board Member of Georgia Guardians ad Litem Inc., and coordinated and lectured at Georgia's first statewide basic and advanced Guardian ad Litem training. She also enjoys mentoring Guardians ad Litem through some of their more difficult cases. Debbie has also been a Board Member of the Center For Navigating Family Change since 2018.

In 2000, Debbie took advantage of an opportunity to live in Barcelona, Spain. She started a thriving tour business giving private, small group tours of Barcelona and surrounding Catalunya. Being born and raised an Atlanta girl, however, she came home in late 2003.
